Wade Trim Foundation Grant Application

In 2025, the Wade Trim Foundation will award five, \$7,500 grants for projects that positively impact the environment, community, and quality of life through innovative infrastructure investments. Sustainable projects with long-term impacts may qualify for additional points during the scoring and selection process.

Our theme is "Investing in Our Communities". Eligible projects include physical improvements to and/or construction of hard infrastructure such as building construction or remodels, parking lots, landscaping, parks, trails, waterways, and public spaces. **Planning and design services and staff** salaries are not eligible,

US-based governmental entities and public charities described in Code Sections 170(c)(2), 2055(a)(2), 2522(a)(2) and 501(c)(3) applying for a Wade Trim Foundation Grant must:

- Not discriminate based on race, age, ancestry or national origin, sexual orientation, gender, physical or mental disability, or religion.
- Not be a political organization, a political action committee, or a house of worship. (We accept applications from organizations with religious affiliations if the project is not specific to or primarily to benefit a religious group).
- Agree to provide photos of the completed project or progress photos for a period of 3 years following receipt of the grant.

If your organization meets our eligibility requirements and your project fits our theme, we encourage you to apply for a Wade Trim Foundation Grant. Applications will be accepted from March 3, 2025, through April 18, 2025. Awards will be announced in June.
