1.03 BIDDING PROJECT

- A. The project has been advertised via Maple Forest Township website and Wade Trim's bidding website.

1.04 DESCRIPTION OF WORK

- A. Bids will be received for the following Work:
 - 1. This project includes the creation of a new park in Maple Forest Township, Michigan. Work to include the construction of a new playground.
 - 2. The Work, known as Maple Forest Park, includes but is not limited to the construction of an ADA playground with rubber mulch surface.
 - 3. The site is located on the east side of North Sherman Road, just south of West Marker Road and the Maple Forest Township Hall in Grayling, Michigan, as shown on the Drawings.

1.05 DESCRIPTION OF GRANT FUNDING REQUIREMENTS

- A. This project is supported by the Michigan Department of Natural Resources Recreation Passport Grant. All relevant state and federal requirements apply.
 - 1. Project is Michigan Recreation Passport Grant PSB-RP23-0032-009.
- B. Contractor and all Sub-Contractors must comply with all requirements of 1976 PA 453 (Elliott Larsen Civil Rights Act), the 1976 PA 220 (Persons with Disabilities Civil Rights Act), and Executive Directive 201909, as amended.
